

Data Protection Policy

1. Overview

- 1.1 The goal of the data protection policy is to depict the legal data protection aspects in one summarising document. It can also be used as the basis for statutory data protection inspections, e.g. by the customer within the scope of commissioned processing. This is not only to ensure compliance with the European General Data Protection Regulation (GDPR) but also to provide proof of compliance.
- 1.2 The General Data Protection Regulation (GDPR) is a regulation, which requires any business that processes data belonging to UK & EU citizens to protect it and not misuse it. As a responsible company, Expeditions for Everyone C.I.C aims to robustly implement the requirements of the GDPR. Part of meeting the obligation of meeting the obligations of GDPR is the production and implementation of this policy.

2. Responsibilities

- 2.1 Expeditions for Everyone C.I.C is responsible for determining what personal data is stored and how it is used, therefore Expeditions for Everyone C.I.C is a Data Controller, in relation to the GDPR.
- 2.2 Expeditions for Everyone C.I.C Responsible Officer for Data Protection Jolene Pattrick, Company Director. Expeditions for Everyone C.I.C, 16 Springfield Close, Buckden, CAMBS, PE19 5UR.

3. Purposes - Why does Expeditions for Everyone C.I.C collect individuals Data?

- 3.1 Expeditions for Everyone C.I.C collects and processes individual data to attribute learner's achievement to awards/qualifications. Learners must supply their data to allow qualification credit to be awarded and a commemorative certificate to be produced. Without individual's data Expeditions for Everyone C.I.C is unable to award qualifications and therefore produce qualification certificates as Expeditions for Everyone C.I.C would be unable to attribute a learner's evidence to the learner.
- 3.2 The legal basis for collecting and processing data falls under the *Legitimate Interests*, heading of the GDPR.
- 3.3 Where Expeditions for Everyone C.I.C intends to gather or use data outside the scope of *legitimate interests*, Expeditions for Everyone C.I.C and the GDPR require that individual consent must be explicitly gained.

Expeditions for Everyone C.I.C will seek individual consent in the following circumstances:

- Opting into marketing communications

Section 7.0



Individuals have the right to remove their consent at any time following its explicit permission. Consent can be revoked by following unsubscribe links on marketing emails and by making a subject access request, completing the Data Request Form (DRF) and following the process described in Appendix 2.

4. Types of data collected and processed

4.1 Expeditions for Everyone C.I.C regularly collects the following personal data (First Name, Surname, Email, Telephone, Mobile, Address, Town, County, Postcode, Country, Date of birth), which allow learners to be awarded credit associated with awards/qualifications.

5. Data Storage

- 5.1 Expeditions for Everyone C.I.C data is stored electronically on password protected, encrypted databases (web based, and office based) and where provided data in paper form it is stored in a secured filing cabinet in the Expeditions for Everyone C.I.C office.
- 5.2 Expeditions for Everyone C.I.C will not keep your personal data for any longer than is necessary considering the reason(s) for which it was first collected. Your personal data will therefore be kept for a period of one year for completion of an online course or 5 years after completion of a practical course. Following the designated period all physical records are securely destroyed and all electronic records are anonymised/pseudonymised.

6. Data processing and usage

- 6.1 When individuals provide their data to Expeditions for Everyone C.I.C, the data is used to:
- a) Attribute qualification credit to learners
- b) Produce commemorative certificates
- c) Register and enrol users on e-learning packages
- d) Managing payments for product and services
- e) Communicating with individuals
- 6.2 Expeditions for Everyone C.I.C only uses data for the legitimate purposes described above. Any changes to the ways in which Expeditions for Everyone C.I.C uses individual's data will be communicated to those individuals affected.
- 6.3 The Expeditions for Everyone C.I.C website may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.



7. The rights of the individual

- 7.1 Under the GDPR individuals have rights associated with their data, described below:
- a) The right to be informed
- b) The right of access
- c) The right to rectification
- d) The right to erasure
- e) The right to restrict processing
- f) The right to data portability
- g) The right to object
- h) Rights in relation to automated decision making and profiling

8. Children's Personal Data

8.1 For the benefit of this policy a child is classed as a young person under the age of 16. Children must have parental (or an individual in loco parentis) consent for Expeditions for Everyone C.I.C to collect and process their data. Expeditions for Everyone C.I.C will maintain evidence of consent using our learner registration process.

9. Subject Access Requests

- 9.1 All subject access requests in relation to individual rights above must be made using form DRF (annex ii) and sent either electronically to staff@expeditionsforeveryone.co.uk or by post to Expeditions for Everyone C.I.C, 16 Springfield Close, Buckden, CAMBS, PE19 5UR.
- 9.2 Expeditions for Everyone C.I.C will acknowledge all subject access requests within 2 working days and will process and respond to all subject access requests within 1 calendar month of receiving suitable Identification, as per Expeditions for Everyone C.I.C' obligations under the GDPR.
- 9.3 To prevent unscrupulous or fraudulent subject access requests Expeditions for Everyone C.I.C require all access requests to be made using form DRF that requires the individual to authenticate their request. Subject access requests will only be fulfilled when the individual has provided suitable identification (photographic e.g. Passport, driving license or other suitable ID). All requests will be securely stored for 5 years unless the request for erasure is requested.

10. Data Breaches

- 10.1 Expeditions for Everyone C.I.C have systems and controls in place to prevent data breaches, however in such an event where individuals data has been lost, stolen or has been accessed by unauthorised parties Expeditions for Everyone C.I.C will notify the Information Commissioners Office (ICO) within 72hrs of the breach.
- 10.2 The following individuals is the point of contact when a data breach has been identified:
- a) Data Breach Response Coordinator Jolene Pattrick



- 10.3 Expeditions for Everyone C.I.C' data breach process is described below:
 - a) Serious data breach identified, and Data Breach Response Coordinator is informed.
 - b) The type of event is identified as lost, stolen, or subject to unauthorized access.
 - c) The event is recorded in PCAP Data Protection Tab.
 - d) The coordinator informs the Information Commissioners Office (ICO).
 - e) The coordinator instigates an investigation, identifies the source of the breach, and puts in places measures to reduce risk and impact.
 - f) The coordinator informs all individuals concerned.
 - g) Expeditions for Everyone C.I.C monitor for further breaches.

11. Making a complaint

11.1 If individuals are dissatisfied with Expeditions for Everyone C.I.C' Data Protection and Privacy Policy or its implementation please see Expeditions for Everyone C.I.C Complaints Policy.

12. Expeditions for Everyone C.I.C Privacy Notice for Learners

12.1 Notice

- a) Expeditions for Everyone C.I.C collect and process your Name, Date of Birth, Address, Email Address, Telephone Number, Ethnicity, National Identity, Signature data in order to produce qualification certificates and monitor the data to ensure we meet our equality and diversity and access to learning obligations.
- b) Failure to provide your data can result in your qualification certificate not being issued.
- c) Your data may be passed, securely on to the UK Government who will utilise it for statistical purposes.
- d) Your personal data will only be accessible to Expeditions for Everyone C.I.C, the course provider and legitimate
- professionals (need-to-know basis) and will not be passed to any other external third party.
- e) Your data will be held for 5 years from the date of your certificate after which point it is destroyed or anonymised.
- f) Individuals have rights associated with personal data which can be found on the ICO website.
- g) You may withdraw your consent for Expeditions for Everyone C.I.C to securely store your data at any time within the 5-year period.
- 12.2 Expeditions for Everyone C.I.C also produces a general privacy policy available on the Expeditions for Everyone C.I.C public website.

Appendix 1

Expeditions for Everyone C.I.C Privacy Notice

Expeditions for Everyone C.I.C is committed to the fair and transparent processing of personal data and data security. This privacy policy sets out how we will manage the personal data, which you provide to us in compliance with the General Data Protection Regulation (EU) 2016/679 (GDPR).

This policy contains important information about who we are, how and why we collect, store, use and share personal data and your rights in relation to your personal data.

This Policy, together with our website terms of use and any other documents referred to in them, sets out the basis on which Expeditions for Everyone C.I.C processes personal data.

Personal data we collect

We may collect and process the following personal data:

Information provided to us, when you:

- Complete a form on our Website
- Contact us by phone, e-mail, or in writing
- Report a problem
- Create an online account with us

We may collect your name, e-mail address, postal address and telephone number.

Information we collect about you:

If you visit our website, www.expeditionsforeveryone.co.uk, we may automatically collect the following information:

- Technical information, including the internet protocol (IP) address used to connect your computer to the Internet, login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- Information about your visit to our website such as the services you searched for and view, page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.



Sensitive personal data:

In certain limited cases, we may collect certain sensitive personal data from you (e.g. information about your racial or ethnic origin and physical or mental health). We will only do this on the basis of your consent.

How Expeditions for Everyone C.I.C uses your personal data

Legitimate interests:

Where this is necessary for purposes, which are in our legitimate interests.

These interests are:

- Providing you with newsletters, surveys, information about our qualifications and events related to products and services offered by Expeditions for Everyone C.I.C which may be of interest to you
- Communicating with you in relation to any problems, complaints, or disputes
- Improving the quality of experience when you interact with us and our products and/or services

NOTE: All individuals have the right to object to the processing of your personal data on the basis of legitimate interests as set out below, under the heading Your rights.

Contract performance:

We may use your personal data to fulfil a contract, or take steps linked to a contract:

- To provide the products and/or services to you i.e. qualifications
- To communicate with you in relation to the provision of the contracted products and services
- To provide you with admin support such as account creation, security, and responding to issues
- Provide you with industry or sector information, surveys, information about our qualifications and events, related to the products and/or services.

Consent:

Where you have given your express consent to receive marketing communications, we may use your personal data to send you newsletters, surveys, information about our awards and events related to products and services offered by Expeditions for Everyone C.I.C which may be of interest to you,.

Where required by law:

We may also process your personal data if required to by law, including responding to requests by government or law enforcement authorities, or for the prevention of crime or fraud.

Who do we share your personal data with?

We take all practical steps to ensure that Expeditions for Everyone C.I.C staff protect your personal data and that they are aware of their information security obligations. Access to your personal data is limited to those who have a genuine operational need to know it.





We may also share your personal data with legitimate professionals outside Expeditions for Everyone C.I.C including:

- Legal and other professional advisers, consultants, and professional experts
- Service providers contracted to us in connection with provision of the products and services such as providers of IT services, Website services
- Law enforcement or other authorities if required by law.

How long does Expeditions for Everyone C.I.C keep your personal data?

Where there is an agreement between us, we will retain your personal data for the duration of the agreement, and for a period of five years following its termination or expiry, to ensure we are able to comply with any legal, audit and other regulatory requirements, or any orders from courts or competent authorities.

Where you give consent to marketing communications, you can change your preferences or unsubscribe at any time by clicking the unsubscribe link in an email from us.

Where we store your personal data and how we protect it

We take appropriate steps to protect your personal data from loss or destruction. We also have a procedure in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Where you have a username or password (or other identification information), which enables you to access Expeditions for Everyone C.I.C services or parts of our website and/or web office, you are responsible for keeping this password confidential. Please do not to share a password with anyone, including Expeditions for Everyone C.I.C.

Unfortunately, the transmission of information via the Internet is not completely secure. However, we will always strive to protect your personal data. We cannot guarantee the security of your personal data transmitted to our Website; any transmission is at your own risk. Once we have received your personal data, we will use strict procedures and security features to prevent unauthorised access.

Your rights

Under the GDPR, you have rights with respect to our use of your personal data:

The Right to:

Access

You have the right to request a copy of the personal data that we hold about you by contacting us at the email or postal address given below. All requests must be accompanied by information, which allows us to verify your identity (ID). We will respond to your request within one calendar month.



Please note that there are exceptions to this right. We may be unable to make all information available to you if, for example, making the information available to you would reveal personal data about another person, if we are legally prevented from disclosing information, or if your request is excessive.

Rectification

We strive to keep your personal data accurate and complete. Please contact us using the contact details provided to let us know if any of your personal data is not accurate or changes, so that we can keep your personal data up-to-date.

Erasure

You have the right to request the deletion of your personal data. Instances of erasure may include, personal data no longer necessary for the purposes for which they were collected, where your consent to processing is withdrawn, where there is no legitimate interest for us to continue to process your personal data, or your personal data has been processed unlawfully.

Object

In certain circumstances, you have the right to object to the processing of your personal data where, for example, your personal data is being processed on the basis of legitimate interests and there is no overriding legitimate interest for us to continue to process your personal data. If you would like to object to the processing of your personal data, please contact us using the contact details provided below.

Restrict processing

In certain circumstances, you have the right to request that we restrict the processing of your personal data. This right arises where, for example, you have objected to processing based on legitimate interests and we are considering whether there are any overriding legitimate interests, or the processing is unlawful and you elect that processing is restricted rather than deleted.

Data portability

In certain circumstances, you have the right to request that some of your personal data is provided to you, or to another data controller, in a commonly used, machine readable (electronic) format.

For any request associated with the rights described above, please contact Expeditions for Everyone C.I.C using the details below.

NOTE: GDPR sets out exceptions to these rights. If we are unable to comply with your request due to an exception we will explain this to you in our response.
